The terms of this application shall remain in full force and effect unless and until Applicant notifies the Company in writing to terminate the account or until terminated by Company. Applicant shall remain responsible for all charges made to the account prior to such termination.

Applicant agrees to pay all expenses incurred in collecting amounts due on the account, including attorney's fees in the amount thirty-three and one third percent (33 $\frac{1}{3}$ %) of the outstanding balance due at the time collection action is commenced. Applicant hereby waives the benefit of homestead and all other exemption rights as to this indebtedness.

Personal Guaranty
