## Terms of Agreement

The undersigned ("Purchaser") agrees that all purchases made by Purchaser from Gusti Restaurant Equipment is subject to the following terms:

1. All amounts due for goods and services purchased from Seller are payable to the address listed on the invoices. Purchaser acknowledges that such amounts are not payable in installments, but are payable in full as stated herein. Standard terms are net 30 days.
2. All amounts due Seller are payable in accordance with the payment terms stated on the invoice granted by the Seller. If any amount due to Seller is not paid in accordance with the payment terms, a delinquency charge shall be added to the sum due. This charge shall equal the amount obtained by multiplying the delinquent balance by 1.75%.
3. Purchaser shall pay Seller a service charge in the amount of \$25.00 for all checks returned by the purchaser's bank.
4. In the event the account is turned over to an attorney or other agency for collection, Purchaser shall pay all reasonable attorney fees and court costs or Collection fees incurred by Seller.
5. Purchaser shall notify Seller by Certified Mail of any change of ownership of Purchaser.
6. If Purchaser claim exemption from sales tax, please attach a copy of the blanket resale certificate. If seller does not receive a signed re-sale certificate from your company, you may be subject to sales tax.
